- 2) I understand and agree that any overdue amount shall bear interest at the rate set out on SITECH Eastern Canada Ltd. invoices, which is a rate of 2% per month (24% per annum) as of the date hereof, and that interest shall be calculated from due date until such amount is fully paid, the whole without prejudice to any other rights or recourses of SITECH Eastern Canada Ltd. I understand and agree that the interest rate is subject to change without notice.
- 3) I understand and agree that my charge account privileges may be cancelled at any time without justification at SITECH Eastern Canada Ltd.'s sole discretion.
- 4) I certify that all the information contained herein is true, correct and complete and I authorize and consent to the receipt and exchange of any credit information by SITECH Eastern Canada Ltd. including the exchange of credit information concerning the customer with any credit reporting agency or any person or corporation with whom the customer has or proposes to have financial relations.
